

ADVERTISEMENT FOR BIDS

School District of the Menomonie Area Middle School Drainage Improvements

Sealed bids for the project designated above will be received for and in behalf of the School District of the Menomonie Area hereinafter referred to as the Owner, at the location listed above, on or before the above-mentioned time and date, at which time they will be publicly opened and read aloud.

Work of this contract consists of fine grading and compacting existing base course, grading existing grass areas, installation of culverts, curb and gutter, 4" of new asphalt placed over base course, and installation of yard drains and storm sewer.

Three lump sum bids will be required for all of the work. The work is divided into 3 bid packages as outlined on the plans. The low bid is expected to be awarded on May 14, 2018. A pre-construction walk-through will be allowed on the project site. Contractors must contact Kevin Tomaszewski if they would like to walk through the project with the owner.

Bids shall be on the forms provided for that purpose and according to the Contract Documents prepared by CBS Squared, Inc., Chippewa Falls, WI 54729.

The Bidding Documents may be seen at the issuing offices of Menomonie School District Office (address listed above), CBS Squared, Inc. (770 Technology Way, Chippewa Falls, WI 54729), the Northwest Wisconsin Builders Exchange (Eau Claire / Altoona, WI).

Each bid shall be accompanied by the Bidder's Bond or Certified Check in the amount equal to at least 5 percent of the amount of the total bid, which shall be forfeited to the Owner in the event the successful bidder fails to enter into a Contract.

Bids shall be directed to the Owner securely sealed and endorsed upon the outside wrapper BID FOR the School District of Menomonie Middle School Drainage Improvements; these bids should be turned in at the District Office at 215 Pine Ave E., Menomonie, WI 54751.

The Owner reserves the right to retain the deposits of the three (3) lowest bidders for a period not to exceed 15 days after the date and time set for the opening of bids. No bids may be withdrawn for a period of 15 days after the date and time set for the opening of bids.

Digital copies of the Bidding Documents are available from CBS Squared, Inc. A fee of \$35, made payable by check to CBS Squared, Inc. will get bidder on Plan Holders List.

Bidders may be requested to submit “Contractor’s Qualification Statement.”

Bidders will be required to provide performance AND payment bonds of 100 percent of the bid amount.

This Work shall be subject to minimum wages and labor standards in accordance with minimum wages as set forth by the State of Wisconsin.

Work may not interfere with school activities. All work must be complete prior to June 25, 2018.

The Owner reserves the right to reject any and all bids, or award the project in a way that best suits the interest of the School District of Menomonie.
